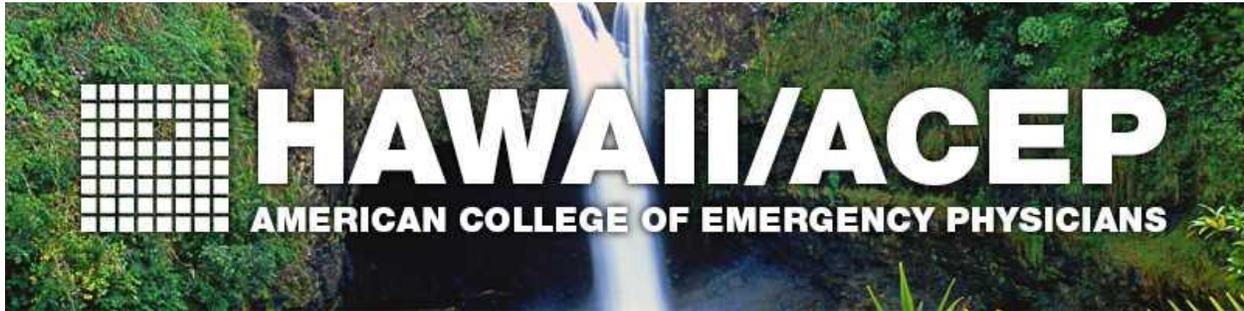

Wellness Hawaii: Physician Mental Health

The last few months have been tumultuous in Hawaii with COVID-19 numbers soaring to new heights and then another lockdown. Mitigation efforts helped control COVID to a certain extent, temporarily anyway. We lost a member of our own Hawaii emergency physician community as well. Dr. Pugera Ganapathy, otherwise known as Dr. G, passed away on September 6, 2020. He was the co-owner of Kunia Urgent Care also working at years at Hawaii Medical Center, and later at Kuakini Hospital. He was one of the most mild-mannered and kindest emergency physicians I have ever known. Now as mainland COVID numbers reach record highs and flu season just around the corner, we must again brace for a difficult winter ahead of us.

With more than 10 million cases in the United States and over 200,000 COVID deaths, sometimes there seems to be no end in sight! Burnout among emergency physicians is high. Working long and erratic hours and having a shifting schedule including nights and weekends, all contribute to this. We are exposed to high levels of stress, at risk for malpractice claims, and making life or death decisions at work. Physicians often do not share their emotions and experiences which may contribute to higher rates of burnout and depression. Often, we are taught that there is no room for error, and we are afraid to be penalized for showing vulnerability and therefore avoid seeking help. Many physicians avoid seeking medical care for their psychiatric problems because they are afraid it will affect their career.

I wrote about Dr. Lorna Breen in the last newsletter. Unfortunately, most physicians that die by suicide, like Lorna, do not seek psychiatric care and their death is often a surprise to their colleagues. After Lorna's death, her family created the Lorna Breen Heroes' Fund to provide mental health support to health care professionals, prioritize the protection and well-being of health care workers, and break down barriers that prevent them from seeking mental health support. The rate of suicide among physicians is higher than in any other profession. On July 29, 2020, the U.S. Senate introduced legislation, the Dr. Lorna

Breen Health Care Provider Protection Act, aiming to reduce and prevent suicide, burnout, and mental health conditions among health care workers. A national three-digit suicide prevention hotline, 988, will be implemented on July 16, 2022.

ACEP has been working on mental health priorities including research on the mental health impacts of coronavirus on physicians and other healthcare providers. ACEP's Wellness hub has peer support and professional counseling. Let's Talk is an online forum which allows its members to discuss challenges in the emergency department or their life in general. You can post here anonymously. COVID Captures is a new platform that records COVID-19 history as it happens, allowing emergency physicians to record firsthand accounts of the pandemic response and giving members a place to record video diaries, processing their COVID-19 experiences with their peers. During these challenging times, we have to take care of ourselves. After all, you cannot take care of others, if you do not take care of yourself.

UH JABSOM Emergency Medicine Interest Group (EMIG)

Good news to report! Students have resumed clinical activities after COVID-19 disrupted medical student education by JABSOM students being temporarily excluded. We do know that nothing can replace bedside teaching and learning. For the residency program, three students are interested in Emergency Medicine with an additional student planning on an Emergency Medicine/Internal Medicine track.

JABSOM received funding from the Emergency Medical Services for Children (EMSC) federal grant through the Hawaii Department of Health to provide pediatric training to paramedics. Two PEDISTEPPS courses were taught at the SimTiki/JABSOM in October. Experienced paramedics, faculty and trainees all felt the course was useful and necessary to practice infrequent skills. Additional courses are planned in 2021. EMSC hopes emergency physicians continue to see improved care for keiki brought to you by ambulance.

The future still offers many unknowns but we all hope that our educational community is well prepared for the challenges to come. And in the true spirit of Aloha, we will face those challenges together!


